### Cancellations

Certain situations may occur that warrant a cancellation. If a situation arises you can re-schedule your session. Similarly, the photographer has the right to cancel for emergencies and inclement weather. However, we will give you a choice to refund your money or re-schedule if that should occur.

### Payment

The total payment is due before or at the time of signing this contract. We will not begin a session until full payment has been received. We accept checks, cash, or online payment on our website. If paying by check we won't begin the shoot until the check has cleared.

### Copyright Ownership

Snake River Valley Photography retains the copyright ownership on all photos taken. We permit you to download digital copies and/or order prints of the photos. We will not sell RAW or unedited photos.

### Digital Downloads

When you purchase or receive a digital download it is to be used for personal use only. You may use it on social media but the photo cannot be cropped or tampered with in any way – such as filters or editing of colors.

### Printing

We recommend ordering prints through our online services, but if you decide to only purchase downloads and print elsewhere, we are not responsible for the quality of the printing. You will receive a photography print release from us when you purchase downloads.

We use WHCC printing lab and if you aren't satisfied with the quality of the prints please notify us so we can address your concerns.

### Liability

SRV Photos is not responsible for injuries occurred during a photoshoot, we realize that the likelihood of an injury or an accident happening is rare. Nevertheless, we have a liability waiver for you to sign before the session begins.

### Extra Fees

1. If you request the shoot to last longer than the original agreed upon length, you will be charged \$60.00 per hour at a prorated fee. We will not charge for setting up or taking down, thus your session time begins when we start taking pictures.
2. If the shoot is 50 miles outside of Pocatello, Idaho we will charge travel mileage at 0.50 cents per mile. Any extra charges are payable by check or cash at the time of the session (if internet service is available you have the option to pay by credit card on our website).
3. Editing includes basic editing such as color balancing and cropping. If you request major editing you will be charged \$60.00 per hour (prorated). We would prefer not to make major adjustments to our photos to maintain the originality of the picture.
